

ANNUAL GIFTS: Monetary gifts to the UMRC Foundation may be made by check or credit card by mail, phone, or online.


ENTRANCE FEE: If you are a resident with an entrance fee, you may want to join your neighbors and donate the refundable portion to the UMRC Foundation.
