YOUR MOST SIGNIFICANT IMPACT MAY BE STILL TO COME! Ensure your legacy through a variety of planned giving options:

WILL OR TRUST: A gift through your will or trust to the UMRC-Porter Hills Foundation:

- Costs you nothing today

QUALIFIED CHARITABLE DISTRIBUTIONS (QCD): A QCD (also referred to as an IRA Rollover) allows donors 70 ½ or older to make tax-free IRA charitable rollover gifts of up to \$100,000 per year <u>directly</u> from their Individual Retirement Accounts to eligible nonprofits, like the UMRC-Porter Hills Foundation.

RETIREMENT PLAN/INSURANCE POLICY: Designate the UMRC-Porter Hills Foundation as the beneficiary of your retirement plan or life insurance policy.

PERSONAL PROPERTY: Gifts of real estate or other personal assets may be accepted, in accordance with legal guidelines and policies of Brio Living Services and the UMRC-Porter Hills Foundation.
