In addition, Dr. Boettcher is a clinical associate professor for the Department of Medicine for Michigan State University College of Human Medicine. Dr. Boettcher has authored many articles and presentations related to geriatrics; most notably, as the principal investigator and author of a system of person-centered care for people living with dementia.

Terrence Quinn, Esq. is a distinguished attorney with over two decades of experience specializing in estate planning and elder law. Terrence's commitment to upholding the highest standards of legal practice and his passion for sharing his knowledge are evident throughout his career.
